

Memorandum of Understanding on League of University Globalization

OBJECTIVES

This Memorandum of Understanding on League of University Globalization (MOU) is to build an international league for universities, closely integrated with their immediate society and economy, to address cultural, environmental, commercial and political issues.

It is agreed that the universities within this league aim to:

- 1. Provide a forum for universities concerned to discuss matters of common interest;*
- 2. Promote greater understanding of the importance of educational globalization through staff and student cooperation, as well as inter-action amongst universities, commerce and local government;*
- 3. Activate a league of University Globalization with universities acting as independent drivers to create ad-hoc or semi-permanent think- tanks on topics particularly relevant to the development of higher education;*
- 4. Develop student and faculty exchanges and provide due help when necessary.*

PROPERTIES OF THE MOU

This MOU is an umbrella agreement, and any other agreements regarding specific cooperation projects or programs to be signed between the universities concerned shall be in conformity with this MOU.

SCOPE OF THE COOPERATION

- 1. Joint research projects of mutual interest;*
- 2. Exchange of faculty members and students;*
- 3. Transfer and articulation of academic courses and programs;*
- 4. Joint academic conferences, seminars, and symposiums;*
- 5. Exchange of information on the research achievements, journals, and research papers of mutual interest;*
- 6. Other cooperation projects or programs of mutual interest*

SIGNING OTHER AGREEMENTS REGARDING SPECIFIC COOPERATION PROJECTS

1. Any other agreement under this MOU shall be reduced to writing and manually signed;
2. Any other agreement under this MOU shall clarify the detailed responsibilities and duties the parties concerned must undertake;
3. Any other agreement under this MOU shall not become effective until it is signed by the legal representatives or the authorized representatives of the parties concerned;
4. The signing and implementation of any other agreements under this MOU are subject to the availability of funds at institutions concerned and/or to the amount of financial assistance obtained by each institution concerned from its external sources.

PERIOD OF VALIDITY OF THE MOU

1. The MOU remains valid for five years starting from the date of signing by the parties;
2. The period of validity will be prolonged for three years automatically after it expires if none disagree in writing with each other to an extension.

TERMINATION OF THE MOU

1. This MOU will be automatically invalid for one party should the party does not agree to extend after the date of expiry; However, it remains valid for all other parties concerned;
2. This MOU will be terminated if it is cancelled. During the period of validity of the MOU, if one party wants to cancel the MOU, it must inform the other parties ninety days in advance of its cancellation and its reasons for the cancellation.

Otherwise, the cancellation will not be acceptable or effective. The MOU will be terminated 90 days after the informed party has received the notification for canceling the agreement by the other parties who are supposed to provide with timely response;

3. If there are students studying courses in the host university under this MOU, an appropriate arrangement will be made to help these students complete their academic program of study in a seamless fashion, with no financial penalty being incurred by the host university.

SOLUTIONS TO THE PROBLEMS AFTER THE TERMINATION OF THIS MOU

- 1. No penalty shall be imposed on the party terminating this MOU. After the termination of this MOU, none of the parties will be held responsible for the economic or other loss to each other caused by the termination.*
- 2. Any disputes arising from any other specific agreements under this MOU shall be settled according to the terms and conditions specified in the agreements concerned.*

LANGUAGES AND HOLDING OF THE MOU

The MOU is made in an English version. It is accepted by each party as the valid and authentic version.

This MOU shall be written in English, and each party holds one copy
