



# MEMORANDUM OF UNDERSTANDING

BETWEEN

SRINAKHARINWIROT UNIVERSITY

AND

KYUNG HEE CYBER UNIVERSITY

Srinakharinwirot University, Thailand, and Kyung Hee Cyber University, Republic of Korea, establish hereby a formal understanding of cooperation, and friendship which is intended to further the academic objectives of each institution and to promote better understanding between the faculty and students of Srinakharinwirot University and the faculty and students of Kyung Hee Cyber University. Under this Memorandum of Understanding, the two institutions will proceed to implement the following endeavors and exchanges of materials and personnel.

## Areas of Cooperation

Assistance shall be carried out, subject to availability of funds and the approval of the competent authority of Srinakharinwirot University and Kyung Hee Cyber University through such activities or program as:

1. Exchange of faculty members
2. Exchange of students
3. Joint research activities
4. Participation in seminars and academic meetings
5. Exchange of academic materials and other information
6. Special short-term academic program
7. Exchange of administrative managers/coordinators
8. Joint cultural program

The terms of such mutual assistance and necessary budget for each specific program and activity that is implemented under the terms of this MOU shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of the particular program or activity and the terms of such program shall be negotiated on an annual basis. Each university will designate a Liaison Officer to develop and coordinate specific activities or program.

## Scope of the Cooperation

The areas of cooperation include, subject to mutual consent, any program offered at either university as felt desirable and feasible on either side and both sides feel contributes to the fostering and development of the cooperative relationships between the two universities.

The assistance to be provided by each of the contracting parties will be teaching, research, exchange of faculty and students, and staff development, etc. as deemed beneficial by the two institutions.



## Implementation

The Memorandum of Understanding shall remain in force for a period of three years upon the date it is signed by the appropriate officials of the two universities. It may be further extended or amended with the written agreement of both parties. This MOU may be terminated by either party subject to the delivery of six months advance notice, in writing.

# AGREEMENT OF COOPERATION

BETWEEN

SRINAKHARINWIROT UNIVERSITY

AND

KYUNG HEE CYBER UNIVERSITY

This AGREEMENT ("Agreement") entered into as of the 22th day of February, 2008, by and between Srinakharinwirot University, Thailand, and Kyung Hee Cyber University, Republic of Korea. This Agreement of Cooperation for reciprocal exchange is based on the 'MOU between Srinakharinwirot University and Kyung Hee Cyber University'.

## Article 1

Agreement is hereby made between the parties for the establishment of a program of reciprocal international exchange whereby faculty and students from each of the respective universities will matriculate at the other university pursuant to the terms and conditions set forth herein.

## Article 2

1. The responsibilities of Srinakharinwirot University are as follows:

- a) To designate and establish 'The KHCYU Study Hall', where their faculty and students can access the online programs of Kyung Hee Cyber University. The operation of this learning venue will be closely coordinated with Kyung Hee Cyber University-appointed technical panel and consultants; and
- b) To recommend the qualified applicants, accomplishing at least 4th level of TOPIK (Test of Proficiency in Korean), for scholarships endowed by Kyung Hee Cyber University.

2. The responsibilities of Kyung Hee Cyber University are as follows:

- a) To provide the program contents for the Korean Language Program for accession to Srinakharinwirot University; and
- b) To make the final decision on the recipients of scholarship grants from the list of applicants, accomplishing at least 4th level of TOPIK (Test of Proficiency in Korean), submitted by Srinakharinwirot University.

## Article 3

All modalities pertaining to activities based on this AOC shall be negotiated and agreed upon between the two parties in each specific case.



#### Article 4

Unless agreed upon specifically, either party shall have no financial responsibility for any expenses incurred by the other party in respect of activities indicated above other than those expressly provided for.

#### Article 5

The AOC shall remain effective for a period of three years from the date of signature. It may be further extended or amended with the written agreement of both parties. This AOC may be terminated by either party subject to the delivery of six months advance notice, in writing.
