

Memorandum of Understanding

Between

Srinakharinwirot University, Thailand

and the

University of Alberta, Canada

The University of Alberta, Canada and the Srinakharinwirot University, Thailand wishing to establish friendly relations, agree to cooperate with each other.

Scope of the Cooperation

In response to the global epidemic of physical inactivity, the above named partners agree to develop an initiative to promote and enhance opportunities for teaching and research in the areas of sport, physical education and recreation for children, youth, and adults in Thailand. The Faculty of Physical Education and Recreation, University of Alberta will share its expertise in these areas and collaborate with Srinakharinwirot University which provides post secondary degree programs in physical education, recreation and sport.

The parties to this agreement will work together to develop and promote opportunities for collaborative education, research and training that will assist to meet the objectives for sport, physical education and recreation for children, youth, and adults in Thailand.

In addition to the above, this MOU will provide a basis for collaboration through such activities as:

- a. Exchange of faculty and/or staff
- b. Programs for the mobility of students
- c. Joint research activities and publications
- d. Participation in seminars and academic meetings
- e. Exchange of academic materials and other information
- f. Special short-term academic and training programs.

The terms of cooperation for each specific activity implemented under this *Memorandum of Understanding* shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of that activity. Any such agreements entered into, as outlined above, will form appendixes to this *Memorandum of Understanding*. Each organization shall designate a liaison officer to develop and coordinate the specific activities agreed upon.


Notification of any change in liaison officers may be made by letter without amending this *Memorandum of Understanding*.


