MEMORANDUM OF UNDERSTANDING FOR ACADEMIC COOPERATION BETWEEN SRINAKHARINWIROT UNIVERSITY AND STATE UNIVERSITY OF NEW YORK

Srinakharinwirot University (SWU), the Kingdom of Thailand and the State University of New York (SUNY), the United States of America establish hereby a formal understanding of cooperation and friendship which is intended to further the academic objectives of each institution and to promote better understanding between the faculty and students of SWU and the faculty and students of SUNY. Under this Memorandum of Understanding, the two institutions will proceed to explore their relationship in the following areas:

Areas and phases of exploration

During the first stage of exploration and subject to availability of funds and the approval of the competent authority of SWU and SUNY, the cooperating institutions may engage in such activities or programmes as:

- 1. Joint research activities
- 2. Participation in seminars and academic meetings
- 3. Exchange of academic materials and other information
- 4. Special short-term academic programmes
- 5. Joint cultural programmes

The terms of such mutual assistance and necessary budget for each specific programme and activity that is implemented under the terms of this MOU shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of the particular programme or activity and the terms of such programme shall be negotiated on an annual basis. Each university will designate a Liaison Officer to develop and coordinate specific activities or programmes.

Scope of the Cooperation

The areas of cooperation include, subject to mutual consent, any programme offered at either university as felt desirable and feasible on either side and both sides feel contributes to the fostering and development of the cooperate relationships between the two universities. The assistance to be provided by each of the contract parties can be teaching, research, exchange of faculty and students, and staff development, etc. as deemed beneficial by the two institutions.

Implementation

The Memorandum of Understanding (MOU) shall remain in force for a period of three years upon the date it is singed by the appropriate officials of the two universities. It may be further extended or amended with the written agreement of both parties. This MOU may be terminated by either party subject to the delivery of six months advance notice, in writing.

DESCRIPTION

At the request of Sumalee Leungsakul, Acting Director, Science Education Center, Srinakharinwirot University (SWU) and The Research Foundation of the State University of New York acting on behalf of and in conjunction with the State University of New York College at Cortland (Research Foundation) will provide support and opportunities for one or more graduate students to visit, study, and perform individual research with the faculty sponsor (Orvil White, Ph.D.) in the area of their dissertation and develop their dissertation proposals for their graduate degree programs (Visiting Scholars). While in residence the SWU Visiting Scholars will:

- Participate with an assigned faculty member in any of their ongoing research efforts in the area of the visiting scholars dissertation area,
- Become engaged with the SUNY Cortland faculty in the review and delivery of instruction for the SWU pre-service teachers, and
- Observe and interact with local elementary, middle and secondary school science teachers.

The SWU faculty of Science Education is interested in pursuing a cooperative relationship between the Research Foundation (acting on behalf of SUNY Cortland) and SWU to facilitate the matriculation of Thai students to SUNY Cortland and create opportunities to extend research internationally.

PROVISIONS

The Research Foundation on behalf of SUNY Cortland will provide:

- Transportation for Visiting Scholars to and from Syracuse, New York and the Syracuse Hancock International Airport upon arrival and for departure.
- SUNY Cortland identification cards to assure campus access and status for Visiting Scholars.

- Assistance in acquiring living accommodations in the SUNY Cortland
 Residential Housing complex or within the Cortland area. These accommodations
 are to be within walking distance to the School of Education and most other
 SUNY Cortland facilities.
- Assistance in purchasing or renting automobiles if needed.
- Orientation to SUNY Cortland's campus, City of Cortland and local shopping areas and nearby cities.
- Full access to the SUNY Cortland library, Information Resource Center and computer laboratories.
- Free local telephone service from office space.
- Health insurance for Visiting Scholars (\$100 Deductible, 100% of the first \$4,000 of expenses; from \$4,000 to \$7,000 insurance will pay 80% and the participant will pay 20%; from \$7,000 to \$100,000 the insurance will pay 100% of medically necessary expenses).
- Welcoming reception with 2 Thai students, 25 faculty, and project staff.

The Research Foundation on behalf of SUNY Cortland will not provide:

- Travel to and from point of origin (e.g., Thailand) and Syracuse Hancock International Airport.
- Living expenses for accommodations while at SUNY Cortland. However, SUNY Cortland will assist in making arrangements for fully furnished guest apartments which will include provisions for cooking, cooking utensils, TV, and all utilities. The apartments are two bedrooms and rent is estimated to be \$1,100 per month.
- Stipends for other living expenses such as entertainment, food, long distance telephone calls, clothing, gifts, other travel, local transportation, laundry, etc.
- Fee remission, books and materials that Visiting Scholars may choose to purchase for professional/personal use.
- Dental or vision insurance.

Srinakharinwirot and/or Visiting Scholars will provide:

- Health and accident insurance for Visiting Scholars family members if they reside in the SUNY Cortland area.
- Cost of all long distance telephone service.
- Cost of individual printing/duplication.
- Cost of any and all conferences, seminars and training sessions that the individuals choose to attend.

TERMS

Srinakharinwirot University agrees to fulfill its responsibilities under any applicable immigration laws and assist Visiting Scholars, to the fullest extent possible, in obtaining visas and other documents required by the government of Thailand. The Research Foundation of SUNY reserves the right to require the withdrawal of any Visiting Scholar whose conduct warrants such action, in consultation with Srinakharinwirot University before finalizing such action, if necessary.

The cost of this program is computed on a sliding scale based on U.S. dollars for two (2) Visiting Scholars (\$21,795). The cost of additional Visiting Scholars is negotiable upon request. Payment is due upon commencement of the program.

The term of this agreement is May 16, 2008 through May 15, 2009. This Memorandum of Agreement is renewable for subsequent years upon mutual consent of both parties.

Each party shall be responsible for any and all liability, claim, loss, damage, suit or judgment arising directly out of the acts of that party or its officers, employees, agents, representatives or students. Neither party shall be liable for the acts of the other, nor shall they be liable for the acts of participants.
