MEMORANDUM OF UNDERSTANDING Between

GRADUATE SCHOOL OF MEDICAL AND DENTAL SCIENCES, FACULTY OF DENTISTRY, TOKYO MEDICAL AND DENTAL UNIVERSITY, TOKYO, JAPAN

And

FACULTY OF DENTISTRY, SRINAKHARINWIROT UNIVERSITY, BANGKOK, THAILAND

This Memorandum of Understanding is made between the Graduate School of Medical and Dental Sciences, Faculty of Dentistry, Tokyo Medical and Dental University, Tokyo, Japan (hereinafter referred to as "TMDU") and the Faculty of Dentistry, Srinakharinwirot University, Bangkok, Thailand (hereinafter referred to as "SWU"). TMDU and SWU are hereinafter jointly referred to as "the Parties" and singularly as "Party".

Whereas the Parties agree to promote joint research and development activities of mutual interest in accordance with their respective needs and objectives, and shall, by joint agreement, determine the areas and subjects of such cooperation, on the basis of the following Articles, this Memorandum of Understanding (hereinafter, "MOU") sets out the understanding of the Parties' collaboration.

Article 1. AREA OF COOPERATION

Upon the mutual consent of both Parties, including other relevant academic management units within the universities, and subject to the availability of funds,

collaboration may be carried out in, but not necessarily limited to, any of the following activities:

- Exchange of students, academic and administrative faculty members, visiting scholars, and other staff members mutually agreed upon by the two Parties or their institutions.
- Official visits between the two Parties or their institutions.
- Collaborative research and publication.
- Sharing of scientific materials, publications, and information.
- Joint organization of conferences, seminars, or academic meetings.
- Joint organization of special technical or administrative programs.
- Joint production and delivery of courses and programs.

Article 2. ADDENDA

Addenda to this document will identify specific projects, which will be undertaken within this overall agreement, and the details of their management. Further addenda may be developed at anytime but will require mutual agreement in writing to be effective.

Article 3. FINANCIAL ARRANGEMENTS

The financial arrangements required for the implementation of this agreement will be settled upon by agreement between the two institutions in respect to each program of cooperation.

Article 4. INTERNAL PROMOTION

Each Party will take action to make the substance of this MOU known to its appropriate personnel, and will provide normal and reasonable assistance to such personnel in regard to the administrative details of exchanges and work agreements.

Article 5. MODIFICATION

Any modifications of this agreement will be undertaken by mutual agreement in writing at any time and any changes will take effect on a date agreed by both Parties.

Article 6. PUBLICATION

The Parties agree that each may publish or advertise the existence and nature of activity under this agreement, provided that the counterpart Party does not indicate in writing that a specific matter should remain confidential.

Article 7. ASSIGNMENT

Assignment of this agreement to any other party or parties is prohibited except with the mutual agreement in writing of the appropriate authorities at TMDU and SWU.

Article 8. EFFECTIVE DATE

This agreement will become effective from the date of the signatures by the representatives of both Parties and valid for an initial period of five years. The agreement will be reviewed not less than six months prior to the natural termination of the current agreement and may be extended or renewed by mutual agreement in writing.

Article 9. TERMINATION

Either Party may, on six months notice in writing, terminate this agreement in advance of its normal expiration or request the renegotiation of its conditions. Under such circumstances, staff members or students who have commenced an activity under the agreement should be allowed to complete the activity, under the conditions in effect at the time notice was given.

Article 10. INTEGRATION

This MOU integrates the agreement between the Parties. Any matter not covered by this MOU will be discussed between the Parties with the purpose of gaining mutual understanding.

Fully accepting the articles stated above, the Parties hereby sign this agreement in two dated copies, in English, with a copy to be retained by each Party.
